1. Section 2.2.1.1 Social Media Administration (Point 1 – Social Media Presence): Should now be read as

- a) Create afresh / modify existing social media presence to have visually appealing, aesthetic pages with good quality content on various social media channels.
- b) The selected SP would have to suggest a minimum of 10 social media channels and maximum of 15 social media channels to the department based on the popularity & usage. And the same should be made operational after finalization from the Department.

2. Section 2.2.1.2 Creation / Content Management (Point 4): Should now be read as

- a) Marking of all electronic content (text, photo, video or otherwise) as copyright of the Election Department, Haryana shall be a pre-requisite before posting on any social media channel.
